Send your petition to the Federal Docket Management System (FDMS) electronically by accessing the public portal: www.regulations.gov.

For a New Petition

- 3. Select "Search" or click your "Enter" button. Regulations.gov will display a Search Results page.
- 4. Select the "Comment Now" icon.
- 5. Under "No. 1 Enter Information" type your name and mailing address and, if you wish, other contact information such as a fax number, telephone number, or e-mail address (Note: Title 14 of the Code of Federal Regulations requires your name and address when submitting a petition).
- 6. In the required "No. 2 Type Comment" field, type or copy and paste your entire petition or type "petition for exemption/rulemaking" and add an attachment (Note: When an attachment is added, it will appear in bold below the "No. 3 Upload File" field. You can remove the document by clicking the red "X" beside the uploaded document).

- 8. To preview your submission select "Preview Comment." A separate browser window will display all the information you have entered thus far. When you are done, close the preview window by selecting close or clicking on the "X" at the top of the browser window.
